#### **ELIGIBILITY:**

- 1. Any female entrepreneurs in APAC\* are welcomed;
- 2. Each company is only eligible to nominate one representative to participate;
- 3. The nominated individual should either be the owner/director of the company or a representative nominated and approved by its board of directors.









## JUDGING CRITERIA:

- 1. HER ingenious ideas and concepts implemented into the business model (30%);
- 2. HER management leadership and profound marketing strategy (20%);
- 3. HER resilience to the ever-changing market landscape in managing risks and finance (20%);
- 4. HER undertaking of social responsibility and application of SDG (20%);
- 5. HER future sustainability and commercial potential (10%).

Bonus Mark: 3% per each workshop attendance (maximum at 9%)

#### AWARDS:

- A maximum of 10 participants would be awarded as "Most Outstanding Female APAC Entrepreneur" upon judging panel's decision, all awardees would obtain trophies from JCI Hong Kong Jayceettes;
- The rewarded "Most Outstanding Female APAC Entrepreneur" is entitled to participate the on-the-day performance-based awards election, presented with a certificate:
  - a. "The Lady who Rocks the Stage"
  - b. "SDGs Wonder Woman"
  - c. "The Most Favourable Girl Boss"
