無人駕駛不是夢

Autonomous driving: From dream to reality

無人駕駛的車,一直是許多科幻電影中經常出現的情節,反映人們對未來生活的無限想像。 隨着近年5G以及人工智能技術日趨成熟,無 人駕駛已不是夢。

現時,無人駕駛車主要以輔助駕駛技術為基礎, 利用車上的感應器接收路面情況,再作出相應 的提示或控制,並透過連接無線網絡,聯繫其 他車輛或智能基建。2018年,國際自動機工程師學會(SAE International)根據車輛的自動化 駕 駛程度,將其劃分為6個級別(0至5)(見圖一),其中1級和2級的車輛允許駕駛者在輔助駕駛系統或部分自動化系統(如車道保持、巡航控制及輔助泊車)的協助下駕駛,目前已正式推出市場,並逐步獲准在國內外的道路上行駛。

級別 Level	自動化駕駛程度 Degrees of driving automation
0級 Zero	無自動化功能,由駕駛者全程操作 No driving automation. The vehicle is manually controlled by the driver.
1級、2級 Level 1 and Level 2	駕駛者在輔助駕駛系統/部分自動化系統的幫助下駕駛 The driver is helped by a driver- assistance system/partial automation system.
3級 Level 3	有條件自動化的過渡性等級,在某些情況下或會要求人類駕駛者介入 Transitional level of conditional automation where the human driver may be asked to intervene under certain conditions.
4級、5級 Level 4 and 5	車輛由高度或完全自動化系統駕駛,無需人類駕駛者介入 The vehicle is driven by a highly or fully automated system without the need for human driver intervention.



內地着力開發 無人駕駛交通工具

內地近年加速發展無人駕駛, 中央到地方政府陸續推出相 關政策規劃,推動汽車、 互聯網、科技等企業積極投 入研發。無人駕駛的士、巴士 目前已在北京、上海、深圳、 廣州、湖南、江蘇、重慶等多



個省市正式落地。在疫情之下,廣州更有科技公司利用時速40公里的無人駕駛車隊把物資送往隔離區域,協助居民防疫。

事實上,內地汽車企業近年不斷提升無人駕駛技術。例如,阿里巴巴投資的無人駕駛技術公司「Auto X」便於今年1月推出了全無人駕駛的士(Robtaxi),在深圳坪山區對公眾開放試乘;百度旗下「Apollo Go」的全無人的士也於5月在北京部分區域行駛,乘客可以用手機應用程式召車。根據國內今年首份無人公交相關運營分析報告一《中國首條 5G無人公交線路運營報告》,目前中國公開道路在運營的無人巴士路線總長達54.6公里,已高居世界第一,是排名第二美國的8.6倍。



借鑒新加坡經驗 鼓勵無人車的研發和應用

近年香港特區政府着力規劃「香港智慧城市藍圖」,鋭意打造香港成為全球領先的智慧城市,當中「智慧出行」(Smart Mobility)更是發展智慧城市不可或缺的一環。為了推動本地業界加快自動駕駛車輛技術測試,運輸署自2017年起為相關車輛發出車輛行駛許可證,測試地點涵蓋西九文化區、香港科學園及香港生產力促進局等。運輸署亦已着手研究法例修訂,以期透過「監理沙盒」的規管概念,容許業界測試創新技術,推動自動車的測試和應用。

與香港鄰近的新加坡,早於2017年已積極引入靈活的「監理沙盒」機制,規定自動車的法律架構,豁免自動車遵守傳統的車輛規例,並授權交通部門就個別自動車試驗計劃訂立具彈性的規則,在確保自動車符合安全規定的同時,不會窒礙研發創新。當地政府亦於公共道路以外地方設置自動車專屬測試場,甚至開放公共道路網絡予自動車進行測試,相關的經驗均值得港府借鑒,以制定適合本港環境的無人車法規。

值得一提的是,無人駕駛車雖能於一定程度上提高運輸效率、降低意外風險和空氣污染等,但同時也帶來新的挑戰和風險,包括法律責任、網絡安全及私隱風險等。隨着5G技術和人工智能技術的不斷突破,加上無人駕駛的發展已成為全球不可忽視的新興趨勢,各國政府定必會加快制定相關的法規,以促進無人駕駛車的發展和應用。與此同時,智能化、網聯化的無人駕駛技術更將顛覆傳統汽車產業的未來,驅使業界加快實現產業結構升級,以提升自身的競爭力。

For decades, autonomous vehicles have been a standard feature of science fiction movies, reflecting people's infinite imaginations about the future. Yet with the development of 5G and artificial intelligence technologies in recent years, autonomous driving is no longer just a dream.

Currently, autonomous vehicles are developed based on assisted-driving technology. Smart sensors in the vehicle receive traffic condition information, which is used to issue corresponding reminders or appropriate actions. Autonomous vehicles can also connect to other smart infrastructures or vehicles through wireless networks. In 2018, SAE International categorised vehicles into six levels (0 to 5) according to their degree of driving automation (refer to Figure 1). SAE Level 1 and Level 2 vehicles feature driver-assistance systems or partially automated systems, which include lane keeping, cruise control, and assisted parking. These vehicles have officially been launched and are in the process of being approved to drive on roads across the globe.

The Mainland is dedicated to developing automated driving transportation

In recent years, the mainland has accelerated the development of automated driving. Both the central and local governments have introduced relevant policies to promote investments in the R&D of automobile, internet, and technology companies. Automated taxis and buses have been introduced in Beijing, Shanghai, Shenzhen, Guangzhou, Hunan, Jiangsu and Chongqing. During the pandemic, tech companies in Guangzhou even made use of automated vehicles with speeds of 40 km/h to send supplies to local citizens in quarantined areas.

Chinese automobile manufacturers have also been dedicated to improving their automatic-driving technology. For example, Auto X, a driverless technology company invested in by Alibaba, launched an automatic taxi, Robotaxi, in January this year. The Robotaxi is available to the public for test rides in Pingshan District, Shenzhen. Another automatic taxi, Apollo Go of Baidu, began to operate in some areas of Beijing in May. Citizens can request rides through the company's mobile application. According to the state's first unmanned public transportation analysis report, titled "China's first 5G unmanned bus line operation report", the length of autonomous bus routes in China has reached 54.6 kilometres. This ranks first in the world and is 8.6 times more than the second-ranking country, the United States

Singapore is an example of encouraging R&D in unmanned vehicles

The government has been highly focused on the "Hong Kong Smart City Blueprint" to turn Hong Kong into the world's leading smart city. 'Smart Mobility" is considered an indispensable part of the development of a smart city. To encourage the local industry in expediting the technical testing of autonomous vehicles, the Transport Department has issued movement permits for autonomous vehicles since 2017. Testing locations have been established in West Kowloon Cultural District, Hong Kong Science Park and the Hong Kong Productivity Council. The Transport Department has also begun to study the legislative amendments required to allow the industry to conduct trials of innovative technology. This is being done through a regulatory sandbox approach to facilitate the trials and applications of autonomous vehicles.

Singapore, Hong Kong's neighbour, introduced an adaptive regulatory sandbox mechanism in 2017, which stipulates the legal framework for autonomous vehicles. It exempts autonomous vehicles from meeting conventional vehicle rules and authorises transportation departments to create flexible rules for individual trials. This allows autonomous vehicles to meet the necessary safety requirements without impeding innovation. Singapore has also set up specific testing venues for autonomous vehicles and has even opened public road networks for autonomous-vehicle testing. These practices are a valuable blueprint for the Hong Kong government to formulate suitable automated-vehicle regulations for the local environment.

Although autonomous vehicles can, to some extent, improve transportation efficiency and reduce the risks of traffic accidents and air pollution, they also bring new risks and challenges. Some of these include legal liabilities, network security and privacy risks. However, with the continuous breakthroughs of 5G and artificial intelligence technologies, the development of unmanned driving has become an emerging global trend. Governments around the world will have to speed up the formulation of related regulations to facilitate the development and application of automated vehicles. Additionally, automated-driving smart technology and IoT will certainly transform the future of the traditional automobile industry, encouraging industry upgrades to enhance the traditional industry's competitiveness.



香港營商優勢 事實勝於雄辯

Hong Kong is a Business-friendly City with a Multitude of Advantages to Ensure Businesses can Flourish


長久以來,香港作為國際商業樞紐,其獨特優勢包括便利的營商 環境、匯聚國際專才、奉行自由經濟、廉潔的社會,以及資金、貨 物、人才、資訊自由流通的優點,深受國際投資者的青睞。根據聯 合國貿易和發展會議發表的《2021年世界投資報告》,香港是 2020年全球第3大的外來直接投資目的地;而世界銀行《2020年營 商環境報告》亦顯示,香港在全球190個經濟體中高居第三位。

美國政府日前發表一份「業務顧問」報告,英文是Hong Kong Business Advisory, 題目為Risks and Considerations for Businesses Operating in Hong Kong,卻「警告」在港經營的美國企業和個人要留意面臨的「營 商風險」。輿論普遍認為,這就是要製造無形的「政治壓力」,動搖 國際社會對香港經濟前景和營商環境的信心。

雖然如此,我相信,國際資本進行商業投資,一定是以事實和數據 為基礎,再配合理性而嚴謹的市場分析,應該不會受到一些空洞而 荒謬的政治指控所左右。

香港美國商會發表聲明亦指出,香港作為國際商業中心具有至關重 要的作用,仍然是東西方貿易和資金流動的重要且活躍的推動者。 商會支持其會員企業繼續抓住在香港的商機。因此我認為:如果美 國政府在發表所謂「營商警告」之前,可以先向在地的香港美國商 會多作調查和溝誦,相信情況會大不一樣。

過去一年,香港新股集資額超過5.000億港元,同比增加超過50%。 目前香港銀行體系總存款額比去年增加逾5%,去年年底的基金管理 資產淨值也比2019年年底增加約20%。外匯儲備超過3.8萬億港元。



香港依然是全球最大的離岸人民幣中心,亞洲最大的對沖基金基地。 外貿出口持續強勁,連續兩個月出口同比增長24%,加上私人消費 開始有起色,零售銷售維持10%以上同比增速。

事實勝於雄辯,只要將上述香港營商優勢中實實在在的關鍵數據, 與西方國家的無理指控對比起來,大家就可以洞悉真相,了解到香 港作為國際商業樞紐堅如磐石的實況。

For a long time, Hong Kong as an international business hub, has equipped with unique advantages comprising of business-friendly environment, gathering international professionals, pursuing highly open economy, a corruption-free society, and free flows of people, goods, capital and information, which continue to be favoured by international institutional investors. According to the "2021 World Investment Report" published by the United Nations Conference on Trade and Development (UNCTAD), Hong Kong is the world's third largest destination for foreign direct investment (FDI) in 2020. On the other hand, Hong Kong has been ranked the world's third easiest place to do business across 190 economies according to the World Bank's "Doing Business 2020 Report"

However, the US government has recently published a business advisory with the title "Risks and Considerations for Businesses Operating in Hong Kong". It warns that businesses, individuals, and other persons, including academic institutions, research service providers, and investors operating in Hong Kong, should be aware of potential reputational, regulatory, financial, and, in certain instances, legal risks associated with their Hong Kong operations due to the alterations of Hong Kong's laws and regulations. The purpose of the action is indisputable. It tries to create invisible political pressure and force US capital to withdraw from Hong Kong and upset the international community on our economic prospects and business environment confidence.

The above-mentioned action of the US government is totally unfounded and makes trouble out of nothing. It is destined to be "using a wicker basket to draw water". I believe that commercial investment by international capital must be based on facts and observable data, coupled with rational and rigorous market analyses, and they would never be influenced by empty and absurd accusations made by the US government. Moreover, this report is not an executive order, which cannot instruct American companies in Hong Kong to fulfil their requests. It would be advisable to disregard the issue as it is simply a waste paper.

The American Chamber of Commerce in Hong Kong (AmCham) issued a statement reiterating that Hong Kong has a crucial role to play as an international business hub and remains a critical and vibrant facilitator of trade and financial flow between the East and West. For these reasons. AmCham supports its member companies to seize business opportunities in Hong Kong. Did the US government achieve a consensus with AmCham before issuing the so-called "Business Warning" or is it just blurted out an unreasonable accusation?

In the past year, Hong Kong's IPO funds raised exceeded HK\$500 billion, a year-on-year increment of more than 50%. At present, the total deposits in the Hong Kong banking system have increased by more than 5% over last year, and the net asset value of funds under management at the end of last year has also surged by about 20% over the end of 2019. Foreign exchange reserves exceed 3.8 trillion Hong Kong dollars. Hong Kong remains the world's largest offshore RMB centre and the Asia's largest hedge fund base. Foreign trade exports continued to be strong, with exports increasing by 24% year-on-year for two consecutive months. Coupled with the recovery in private consumption, retail sales maintained a year-on-year growth rate of more than 10%.

Facts speak louder than words. As long as we compare the key facts about Hong Kong business advantages with the unreasonable accusations made by the US government, we can shed light on the lies, gain insight into the truth, and understand the rock-solid reality of Hong Kong as an international business hub.



城大突破性研究 有助對抗「三陰性乳腺癌」 提高患者的存活機會

CityU achieves breakthrough in battling Triple-Negative Breast Cancer to improve survival chance

三陰性乳腺癌是一種入侵性強、難以預測且死亡率高的乳腺癌,目前主要療法是化療,但臨床效果並不理想。

由香港城市大學生物學家領導的研究團隊,成功發現一組與治療三 陰性乳腺癌有重要關連的基因。研究成果將有助研發針對三陰性乳 腺癌的藥物,提高患者的存活機會。這項突破性研究亦於《自然通 訊》發表,題為「使用多組學分析法界定影響三陰性乳腺癌的超級 增強子圖譜」。

研究由生物醫學系副系主任王鑫博士及助理教授錢玥明博士帶領。 團隊使用「多組學分析法」,對超過4,000名乳腺癌病人的臨床資料 ,以及多達21個細胞系的多層次表觀遺傳基因測序數據,進行深入 的數據分析,針對所有不同種類的乳腺癌,找出對應的特異超級增 強子,建立出一個調控網絡。

獨特的超級增強子,會刺激與三陰性乳腺癌有重要關連的基因,使之變得活躍;若除去這些超級增強子,能減慢腫瘤增長。

王博士説:「根據基因調控網絡,我們發現FOXC1這個基因,是調控癌細胞增長及轉移的關鍵轉錄因子,並由三陰性乳腺癌特異的超級增強子驅動。在小鼠的實驗中,我們證實了超級增強子驅動FOXC1會促進癌細胞的生長。」


乳腺癌的研究大多著眼於找出不同種類乳腺癌的基因突變,但鮮有研究「表觀遺傳迴路」如何影響乳腺癌。

基因突變是指DNA一部分或多個部分的序列發生變化,而表觀遺傳改變同樣會改變基因組的DNA,但並非改變其序列,而是從DNA序列上增加或移去稱為「表觀遺傳標記」的特殊標記,由此改變人體內蛋白質的運作;而超級增強子便包含了這種特殊的表觀遺傳標記。因此,若超級增強子出現異常調控,便會產生大量可驅動癌細胞增長的蛋白質,從而刺激癌症形成。

錢博士説:「這些研究成果顯示,表觀遺傳基因圖譜對於找出影響 三陰性乳腺癌的關鍵因素大有作用,由此可發掘針對這種入侵性強 的乳腺癌的更有效治療目標。」

Triple-Negative Breast Cancer (TNBC) is an aggressive type of breast cancer with a poor prognosis and a high fatality rate. Chemotherapy is currently the major treatment option but the clinical result is unsatisfactory.

A research team led by biologists at City University of Hong Kong has identified a set of specific super-enhancers that stimulate the activity of the TNBC genes, and that deleting certain specific super-enhancers can reduce tumour growth. The findings may help discover new effective drug targets for TNBC patients to improve their survival chance. The research has been published in Nature Communications under the title "Defining super-enhancer landscape in triple-negative breast cancer by multiomic profiling".

Led by Associate Head Dr Wang Xin and Assistant Professor Dr Rebecca Chin Yuet-ming in the Department of Biomedical Sciences, the research team used the method of multiomic profiling to perform in-depth data mining and built a specific super-enhancer-target regulatory network for a types of breast cancer by integrating multi-level epigenomic sequencing data for 21 cell lines with gene expression data and clinical information for over 4,000 patient samples.

Dr Wang said, "Based on the regulatory network, we identify the gene FOXC1 as a key regulator of cancer growth and metastasis that is driven by a TNBC-specific super-enhancer. We have also demonstrated that super-enhancer drives FOXC1 expression and enhances cancer growth in mouse models."

Traditionally, cancer research has focused on identifying gene mutations in different types of breast cancer. However, how the epigenetic circuit affects cancer remains poorly characterised.

While genetic mutation is a change in one or more parts of the DNA sequence, an epigenetic change also changes a gene's DNA, but not at the sequence level. Instead, special marks called epigenetic marks, are added to or removed from the DNA sequence to change how a protein works in the body. Specific epigenetic marks are contained in super-enhancers. Deregulation, meaning abnormal regulation, of super-enhancers can therefore induce high production of cancer driver proteins and promote cancer formation.

Dr Chin said, "These findings demonstrate the power of leveraging the epigenetic landscape to identify novel players in TNBC, paving the way to discover more effective therapeutic targets for this aggressive form of breast cancer."

以科技解決營商痛點 突破產量瓶頸 全自動急凍雞蛋仔生產機創「再工業化」新里程

Technology Solution Overcomes Productivity Bottlenecks Smart Egg Waffle Making System Sets New Milestone for Reindustrialisation in Hong Kong


本地初創企業「香港街食有限公司」首創急 凍雞蛋仔,鋭意把這種香港傳統特色小食帶 到全球華人市場。為提升產量,公司去年委 託香港生產力促進局(生產力局)研發 「自動化雞蛋仔生產機」,解決營商痛點。 項目更獲得香港特區政府創新科技署創新及 科技基金轄下的「投資研發現金回贈計劃」資 助,最多可獲回贈項目開支40%,順利築建 創業夢。

「香港街食」成立早期,沿用傳統全人手製作方法,以6個電烤爐和計時器生產雞蛋仔,再以人手包裝及急凍,但要3個月才能夠生產一個凍櫃容量的雞蛋仔。若要將產品拓展至內地及海外市場,就必須靠科技解決量產問題。雖然公司曾於台灣購置機器,但最後因技術、機器設計不符合製造雞蛋仔的水平和要求,「失敗」收場。

直至2020年2月,香港街食決定委託生產力局研發「度身訂造」自動化急凍雞蛋仔生產機,最終用了8個月時間研發,於同年11月下旬起開始試用,並於今年1月初正式投產,現時機器每日產能佔公司全盤生產達8成。



生產力局在研發過程中,特意把機器設計成「轉圈」運行方式,製作最多產品見稱,一部機器可同時製作9底雞蛋仔,一小時可以製作54底,盡用所有空間。 HKPC team designed a continuous circular motion to minimise the production space required and increase the production output. The system consists c nine waffle panels which allows for the making of nine egg waffles at the same time – 54 pieces per hour.



機器由倒漿、打開模板、蓋板到180度反轉均為自動,並內置熱度控制系統,無論力度、熱度均依足客戶製作 雞蛋仔的特定配方及要求,達至產品形狀及顏色都符合標準。

The automation process executes the egg batter pouring, waffle panel and 180 degree flipping. With the build-in heat control system, the customers' requirements and needs for their specific egg waffle formula are met delivering standardised product shape and colour.

機器佔地是不少企業要考慮的因素,香港街食亦不例外。故此,生產力局在研發過程中,特意把機器設計成「轉圈」運行方式,節省多達75%空間,另外,機器亦以製作最多產品見稱,一部機器可同時製作9底雞蛋仔,將原本9個師傅的工作,變成了1個人操作,產量亦由每小時12底增至54底。而機器亦只有1.2米長及闊,以及1.7米高,底部亦裝有4個滑輪,令機器可隨意「走位」。

製作一底美味的雞蛋仔,講求師傅的「手勢」,機器又能否做到這點?這部自動化機器能夠高度模仿人手製作傳統雞蛋仔的獨有手勢,就連師傅「反轉」及左右搖勻雞蛋仔那一下手勢也盡量模仿十足。機器更是由倒漿、打開模板、蓋板到180度反轉均為自動,並內置熱度控制系統,無論力度、熱度均依足客戶製作雞蛋仔的特定配方及要求,達至產品形狀及顏色都符合標準。

另外,機器亦可以感應到操作人員已取出雞蛋仔,並在數秒後自動關閉模具,以節省時間。生產力局更為機器加裝安全系統,當雞蛋仔機轉動時,如感應到有手等物體伸入機器內,自動感應器會令機器即時停止,減低工業意外的機率。

展望未來,生產力局團隊將為香港街食進一步增加自動化生產程序 以提升產品質素,並繼續為中小企及初創企業解決營商痛點、推動 香港「再工業化」和擦亮香港製造品牌出一分力。



Local start-up Hong Kong Street Eats Limited runs the first-ever frozen egg waffle business. It aims to promote this traditional Hong Kong snack to Chinese around the world. To increase productivity, it recruited the help of the Hong Kong Productivity Council (HKPC) last year to design an automated Smart Egg Waffle Making System to tackle its business pain point. The project managed to successfully apply for the Research and Development Cash Rebate Scheme under the Innovation and Technology Fund of the Innovation and Technology Commission, receiving a cash rebate of up to 40% of a company's eligible expenditure, to enable the realisation of the dream of starting a business.

In the early days of the operation, all egg waffles were handmade, using 6 electric ovens and timers while being packed and frozen manually. However, it would take about 3 months to produce a freezer load of frozen produce egg waffles. For expansion to the mainland China and overseas markets, technology is a must for mass production. The company had in the past tried to resolve the issue with machines purchased from Taiwan but their technology and machine design were unable to meet the standard and requirements of egg waffle making.

Then in February 2020, Hong Kong Street Eats decided to ask HKPC to develop a customised automatic frozen egg waffle making system. After taking 8 months for development, the system began testing in late-November the same year. Since officially put into operation in early-January this year, the system has helped the company produce around 80% of its daily egg waffle output.

For many companies, including Hong Kong Street Eats, machine footprint is a main factor of consideration. To this end, HKPC team designed a continuous circular motion to minimise the production space up to 75%. Moreover, as the system is equipped with nine waffle panels, i effectively turns the work of 9 egg waffle cooking masters into a one-man band and raises the production output from 12 pieces per hour to 54 pieces. Meanwhile, the system is in size with a dimension of around 1.2m width x 1.2m length x 1.7m height. Fitted with four wheels at the bottom the machine can be placed anywhere.

To make a delicious egg waffle, the egg waffle-making master's skill is essential. Can machine ever replicate this? The smart egg waffle making system can closely imitate the unique cooking habit of a well-trained egg waffle cooking master, including reversing and shaking the egg waffles. The automation process also performs egg batter pouring, waffle panel and 180 degree flipping. With the built-in heat control system, customers' requirements and needs for their specific egg waffle formula are met, delivering standardised product shape and colour.

In addition, the system can sense that the operator has taken out the egg waffles. To save time on production, the waffle panel will be automatically closed after a few seconds. HKPC has added a safety system so that in case of an object (e.g. hand) being detected inside the rotating egg waffle machine, the sensor will stop the system automatically to prevent accidents.

Looking forward, HKPC targets to enhance further the automatic production process for Hong Kong Street Eats for higher product quality. It will also continue to help SMEs and start-ups solve their business pain points, contribute towards the reindustrialisation of Hong Kong and make the "Made in Hong Kong" brand shine on the international sage.

"One Pass" Reform Pilot of the Enterprise Approval Service in Guangdong

為進一步深化「放管服」改革,優化營商環境,廣東省人民政府於 6月7日發布關於《廣東省「一照通行」涉企審批服務改革試點實施 方案》的通知(粤府辦[2021]14號),表示在5月底前廣州、深圳、 珠海、佛山、東莞、中山等地試點開展「一照通行」改革,目標到 12月底前試點城市完成第一批14項改革事項,並在全省範圍啟動 「一照通行」改革;2022年6月底前試點城市完成第二批16項改革 事項。有關內容包括:

- 1. 按需組合「一次申辦」:開展餐飲、住宿、零售、娛樂、居民服 務等多業態經營,再造涉企審批服務,將企業分別向不同部門申 辦相關許可證的模式,改為按需組合、一次申辦,提供更多高頻 事項集成服務。企業辦理營業執照時,可同時申辦多個相關許可 證件。逐步推動證照變更、註銷聯動辦理。
- 2. 並聯審批「一鍵分辦」:簡化優化審批流程,相對統一聯辦事項 審批周期,對簡單業務接件即辦,連同營業執照在1個工作日內 發放;對複雜業務按照壓縮時限50%的目標,簡化辦理流程和內 部審批鏈條。
- 3. 推進商事登記確認制改革:2021年將商事登記確認制試點範圍 擴大至廣東自由貿易試驗區,積極爭取國家授權,進一步向珠三 角9市延伸。依法放寬市場准入,對符合條件的香港、澳門企業, 可在深圳經濟特區直接辦理從事生產經營活動登記,取得營業執 照,從事外商投資准入負面清單以外的生產經營活動。加快推進 商事登記確認制特區立法,為深化改革、持續創新提供法治保障。
- 4. 推動涉企經營事項「港澳通辦」「一照通行」:整合提升粵港澳 大灣區各地市商事登記及行政審批系統,通過對接省「一網通辦」 系統,實現商事登記、涉企經營許可事項「灣區通辦」、「跨境 同辦」、「一照通行」。推進粤港澳三地企業登記信息共享、 資質互認。通過與港澳相關服務機構合作,進一步深化商事登記 「灣區通辦」,實現港澳資企業登記註冊離岸辦理。

environment, the Guangdong Provincial People's Government issued the *Notice on the Implementation Plan for the "One Pass" Reform of the Enterprise Approval Service Pilot Program of Guangdong Province* on June 7 (Guangdong Provincial Government Office [2021] Notice No. 14), By the end of May, the "One Pass" reform will be piloted in Guangzhou, Shenzhen, Zhuhai, Foshan, Dongguan, Zhongshan and other regions. The target is to complete the first batch of 14 reform items in the pilot cities by the end of December, and launch the "One Pass" reform in the whole province. By the end of June 2022, pilot cities will have completed the second batch of 16 reform items. Items include:

- "Single application" on demand: Revamp the approval services related to enterprises of multi-business operations such as catering, accommodation, retail, entertainment, and residential services, change the mode of enterprises applying for relevant licenses from different departments, to a single application based on demand, and provide integrated service for frequently items. When an enterprise applies for a business license, it may apply for multiple relevant licenses at the same time. Gradually promote the joint handling of license alteration and cancellation.
- Joint approval for "One-Click Application": Simplify and optimise the approval process, and coordinate the approval cycle of joint items. Process application instantly for simple businesses and issue the documents and the business license within 1 working day. For complicated businesses, simplify the handling procedures and internal approval chains to reduce 50% of the processing time.
- business registration confirmation system pilot to the Guangdong Pilot Free Trade Zone in 2021, actively strive for national authorisation, and further extend it to the nine cities in the Pearl River Delta. Loosen market access by the law. Enterprises from Hong Kong and Macao that meet the requirements may register their production and business operations directly in the Shenzhen Special Economic Zone, obtain business licenses, and engage in production and business activities outside of the Negative List of Foreign Investment. Speed up the legislative work on the business registration confirmation system in the SARs to provide legal guarantee for continuous reform and innovation.
- business registration and administrative approval systems of all cities in the Greater Bay Area, and realise cross-border "One Pass" business registration and license application by docking with the provincial "Single Network Access' system. Promoting registration information sharing and mutual recognition of qualifications among enterprises in Hong Kong, Macao and Guangdong. Facilitating the commercial registration within the Greater Bay Area through cooperation with relevant service agencies in Hong Kong and Macao, and realising offshore registrations of Hong Kong and Macao enterprises.
