# Personal Information Collection Statement 收集個人資料學明

1. China Friend Development Limited ("China Friend") for the purpose of operating the Fleet Card programme and providing ongoing services to the Customers from time to time, may collect the following personal data and information from the Customer: name, address, telephone number, email address and vehicle registration number and other relevant date ("Personal Data"). If the Customer fails or refuses to provide the Personal Data, China Friend may reject its application or terminate its participation in the Fleet card Programme, and may terminate any or all services provided to the Customer. The Customer expressly consents that China Friend is entitled to obtain Personal Data relating to the Customer from any third parties at any and all times, including without limitation conducting checks with any third party for the purpose of ascertaining whether the Customer is a member or participant of any other promotional programme operated by China Friend or any other programme in which China Friend is one of the providers.
