Young Industrialist Awards of Hong Kong 2021

宗旨

「香港青年工業家獎」為香港工業總會(工總)的年度盛事,於1988年首次舉辦,旨在表彰成就超卓、對香港經濟及社會發展有傑出貢獻的年輕工業家,從而啟發更多青年才俊投身工業,實踐和發揚香港工業追求卓越的精神。

參選資格

候選人須符合下列各項資格:

- (一) 截至2021年5月31日止,年滿21歲又未足46歲 (即1975年6月1日或以後出生):
- (二) 持有香港身份證;
- (三) 服務機構為香港註冊的公司,並主要從事工業;
- (四) 經個人或機構提名。

評審準則

工總邀請社會賢達及資深工業家組成具威望的評審委員會,按候選人的成就、遠見、貢獻及誠信挑選得獎人。

成就 : 所屬企業的營運狀況良好,業績優越。

遠見 : 具創意及前瞻性思維,準確掌握所屬行業及經濟走勢。

貢獻 :熱心推動行業發展,積極投入社會服務,願意履行企業社會

責任,為香港貢獻一己所長。

誠信:品行端正,誠實可靠,業務操守受同儕認同。

提名程序

截止提名日期:2021年5月31日(星期一)香港時間23時59分

(經網上/電郵方式遞交,時間將以主辦機構伺服器之時間為準;經郵寄方式遞交,日期將以郵戳為準。逾期遞交將不獲受理。)

OBJECTIVES

The "Young Industrialist Awards of Hong Kong" has been an annual flagship event of the Federation of Hong Kong Industries (FHKI) since its inception in 1988. It aims to honour outstanding young industrialists with significant achievements and commendable contributions to the economic and social development of Hong Kong, as role model to inspire the next generation and arouse their dedication to industry and pursuit of excellence.

ELIGIBILITY

To be eligible, a candidate must be:

- . Aged between 21 and 45 on or before 31 May 2021 (i.e. born on or after 1 June 1975);
- 2. Holder of Hong Kong Identity Card;
- Working for a Hong Kong-registered company principally engaging in manufacturing; and
- 4. Nominated by an individual or an organisation.

JUDGING CRITERIA

The FHKI will form a reputable judging panel comprising prominent public figures and leaders of industry to select awardees based on the achievements, vision, contributions and integrity of candidates.

Achievements: Business in good shape with sound performance.

Vision: Creative, farsighted and with a good grasp of economic and

industrial development trends.

Contributions: Committed to industry and advancing its progression, dedicated to

community service and corporate social responsibility, and

contribute to the betterment of Hong Kong.

Integrity: Honorable and with respectable personal integrity and business

ethics

NOMINATION PROCEDURE

Deadline for Nomination: 31 May 2021 (Monday) HKT 23:59

(For application by online system/email, the deadline will be based on the server time of the Organiser; for application by post, the postmark date will be regarded as the date of application. Late application will not be accepted.)

Each nomination must be submitted in the prescribed form endorsed by both the nominator and the nominee by online system/e-mail/post, together with supporting documents and application fee to the FHKI by the nomination deadline.

Members of the judging panel and employees of the organiser are not eligible to nominate or to be nominated.

Nominators may submit as many nominations as they wish. Separate nomination forms should be used for each nominee.

Each nominee should submit the following documents for examination:

- 1. A copy of the nominee's Hong Kong identity card;
- 2. Company brochure(s) and/or annual report(s) and/or prospectus;
- 3. Copy of Business Registration Certificate;
- Product catalogue(s) (if any);
- Audited and consolidated financial statements for the past three years (fiscal year 2018, 2019 & 2020);
- 6. List of shareholders (if any);
- Copies of commendations, statements of authorities, honours and awards which testify to and substantiate the nominee's achievements or contribution; and
- 8. An organisation chart indicating the position and responsibilities of the nominee.

Information submitted by the nominator and nominee will be taken into account by the screening committee and the judging panel when assessing merits of the nominee. Providing as many details as possible would facilitate the judging process.

All information furnished will be kept strictly confidential except for evaluation by the screening committee and the judging panel. Appropriate information will only be released if an award is granted.

IUDGING

Final judging: 12 August 2021 (Thursday)

Preliminary Screening

The screening committee reviews all the nominations and selects those they consider should be recommended to the judging panel for consideration.

Final Judging

Only shortlisted candidates recommended by the screening committee will be notified in writing after the preliminary screening and invited to attend the final judging session.

The shortlisted candidates must attend final judging session to be eligible for an award.

OBJECTIVES

To honour an outstanding industrialist who has made significant contributions to Hong Kong industry and community.

ELIGIBILITY

There is no age limit. The nominee must be a Hong Kong resident and engage in industry. Members of the judging panel and employees of the organiser are not eligible to nominate or be nominated.

JUDGING CRITERIA

Selection is based on the nominee's contribution to the Hong Kong industry and community, with a proven track record.

NOMINATION PROCEDURE

Deadline for Nomination: 31 May 2021 (Monday) HKT 23:59

(For application by online system/email, the deadline will be based on the server time of the Organiser; for application by post, the postmark date will be regarded as the date of application. Late application will not be accepted.)

Nominations are open to the public. Nominators do not need to inform their nominees upon submission of the nomination forms.

IUDGING

Final judging: 12 August 2021 (Thursday)

Preliminary Screening

The screening committee reviews all the nominations and selects those they consider should be recommended to the judging panel for consideration.

Final Judging

The judging panel will be responsible for selecting an Award winner. The judging process and award presentation will be conducted together with the "Young Industrialist Awards of Hong Kong".
